- 1) The applying business/company is an existing non-residential customer receiving electric utility service from Gainesville Regional Utilities.

- 2) The applying business/company has a minimum annual average electric usage of 400,000 kilowatt hours per month, calculated as the total kilowatt hours usage during the previous 12 full months divided by 12.

- 3) The applying business/company does not have any delinquencies in payment of its GRU bill within the 12 months immediately preceding the application date.

- 4) The applying business/company is engaged in manufacturing (as defined in Sector 31-33 of the North American Industry Classification System, as same may be updated from time to time) within the Gainesville Enterprise Zone Area.

- 5) The applying business/company must demonstrate that it is actively seeking to relocate its manufacturing operations outside of the Gainesville Enterprise Zone Area or that it is seeking to expand (defined as minimum additional average annual monthly usage of 100,000 kilowatt hours on the same site and not transferred from another site receiving GRU electric service) its manufacturing operations within the Gainesville Enterprise Zone Area.

APPLICATION PROCESS:

The Business/Company further stipulates that it conforms to the Application Process for the program as contained in Ordinance No. 170722 (Section 3-2 (a) (3)) adopted by the Gainesville City Commission on February 1, 2018. These requirements are as follows (please provide written confirmation in the space provided as well as appended documentation to demonstrate affirmatively applicant meeting of the requirements):
